THE KEYS TO SUCCESS ARE THAT MEMBERS SELECT THEIR OWN GROUP OF FIVE, START WITH SAVING EVEN A SMALL AMOUNT, PARTICIPATE IN WEEKLY MEETINGS TO DISCUSS THEIR LOANS, AND SUPPORT EACH OTHER AS THEY SUCCESSFULLY PAY BACK THE LOANS. AS MEMBERS PAY BACK THE LOANS, WHICH HAVE A FIXED INTEREST RATE AND PAYBACK PERIOD, THEY BECOME ELIGIBLE FOR LARGER LOANS TO START AND SUPPORT THEIR INCOME GENERATING ACTIVITIES. EVENTUALLY, MEMBERS ARE ELIGIBLE FOR HOME LOANS WITHIN JAMII BORA'S PLANNED COMMUNITY OUTSIDE NAIROBI. THIS OFFERS A PATHWAY FOR MEMBERS TO MOVE OUT OF THE SLUM AREAS. JAMII BORA OFFERS HEALTH, LIFE, AND DISASTER INSURANCE COVERAGES, BUSINESS SKILLS, EDUCATION, AND EVEN ENGLISH AND SWAHILI AS SECOND LANGUAGES. MPA ALSO PROVIDES GRANTS TO

THE PARTICIPATING FAMILIES PREPARE THEIR FARMS (TYPICALLY ONE ACRE) TO BE SELF SUSTAINING AND SURVIVE THE RAINY SEASON. THE PROJECT REQUIRES THAT THE FAMILIES INVEST IN THEIR FARMS BY BUILDING A ZERO-GRAZING SHED FOR THE COW, PLANTING SUFFICIENT GRASS TO FEED THE COW, AND IMPLEMENTING SANITATION REQUIREMENTS FOR THE FAMILY AND THE COW, IN ORDER TO KEEP THE COW IN GOOD HEALTH.
