THE KEYS TO SUCCESS ARE THAT MEMBERS SELECT THEIR OWN GROUP OF FIVE, START WITH SAVING EVEN A SMALL AMOUNT, PARTICIPATE IN WEEKLY MEETINGS TO DISCUSS THEIR LOANS, AND SUPPORT EACH OTHER AS THEY SUCCESSFULLY PAY BACK THE LOANS. AS MEMBERS PAY BACK THE LOANS, WHICH HAVE A FIXED INTEREST RATE AND PAYBACK PERIOD, THEY BECOME ELIGIBLE FOR LARGER LOANS TO START AND SUPPORT THEIR INCOME GENERATING ACTIVITIES.
