AS MEMBERS PAY BACK THE LOANS, WHICH HAVE A FIXED INTEREST RATE AND PAYBACK PERIOD, THEY BECOME ELIGIBLE FOR LARGER LOANS TO START AND SUPPORT THEIR INCOME GENERATING ACTIVITIES.
